Report on One Day Workshop on "Entrepreneurship Skills" on 20th August 2023

Shahaji Law College, Kolhapur organised a One Day Workshop on "Entrepreneurship Skills" on 20th August 2023. The seminar focused on Conceptualization of Entrepreneurship, Entrepreneurship - Laws for incorporation in India as well as Contracting and Accounting. The programme started at 9:00 am with the welcome address by Professor Dr. M. C. Sheikh. More than 200 students of LL.B.-II were present for the programme.

Introduction of the programme and resource persons were welcomed by Principal, Dr. P. B. Patil.

The Session-I of the workshop began with expert, Professor Dr. M. C. Sheikh, he enlightened students with information about grass root knowledge about entrepreneur and entrepreneurship. His speech began with philosophy and characteristics of Entrepreneurship. Thereafter, he explained the history and development of Entrepreneurship in India. He also helped to understand the concept of social and commercial Entrepreneurship. In addition, he also covered the points related to basic skills and functions of Entrepreneurship. His speech was followed by question and answer session in which students get their doubts solved.

Ms. Payal Prafful Jain (Senior Advocate and Faculty of Sanjay Ghodawat Institute, Hatkanangale, Kolhapur) continued the Session-II on the topic "Entrepreneurship : Laws for incorporation in India". Her speech began with Incorporation of Companies (Public, Private, One Person Company) and it's MOA, AOA as well as Alteration Process according to Companies Act, 2013. She also informed about the registration process, grounds of dissolution for partnership firm according to Indian Partnership Act, 1932. Thereafter, she continued the session with information related to registration process, grounds of dissolution for Limited Liability Partnership (LLP) according to Limited Liability Partnership (LLP) Act, 2008. In addition, she also covered the points related to Shop and Establishment Act, Ministry of MSME and GST Registration. Her speech was followed by question and answer session in which students get their doubts solved.

She started her speech with the concept of 'Proposal', 'Acceptance', 'Agreement', 'Contract' and 'Consideration'. She explained the meaning of those concepts. She explained the essentials of valid contract according to Indian Contract Act, 1872. Thereafter, she gave an explanation about discharge of contract and remedies for breach of contract. She also defined the concept of 'Balance Sheet' and 'Book Keeping' along with its types. She further continued her session with detailed information regarding Income Tax Act, 1961 and explained the basic concepts of ITR, TDS, Set-Off, Counterclaim, Exemption, etc. Her speech was ended with question and answer session in which students get their doubts solved.
