



REPORT OF CIVIL COURT ATTENDANCE (FROM 11TH FEBRUARY TO 20TH FEBRUARY)

In the name of part IV of BCI rules 2009. The BCI have laid down the guideline regarding the legal education syllabus in India that in every academic there should be one practical subject to give the realistic approach regarding the procedural aspect of the court.

Accordingly we have acquainted with the **moot court exercise and internship for the final year.** Under this subject we had an opportunity to visit observe and acquire practical knowledge of **civil court, criminal court and advocate chamber etc.**

The main objects of this subject are to acquire the practical knowledge, to observe procedure of the court, to get acquainted and familiar with the documentation from filing of the suit to the decree.

We have started the court attendance of Civil Court from **11th February 2019 to 20TH February 2019.** We have observed the various types of civil proceeding such as Summary suit, Regular Civil Suit, Special Civil Suit, Miscellaneous applications etc. Also we have observed the interpretation of Statute by various advocates and we also observed how the junior advocates represent the cases.

In due course of this visit we have also got the opportunity to interact the Hon'ble judiciary who guided and discussed about advocacy, judicial examinations, bar bench relations and carrier opportunities.



From 21st March 2019 to 30th March 2019, Roll Nos. 01 to 10 of IIIrd LLB Old Course and Roll Nos. 41 to 45 of Vth NLC from the esteemed Shahaji Law College coming under Shivaji University visited Kolhapur District and Sessions Court located at Bavda for observing Criminal Court proceedings under the guidance of Professor Dr. M.C. Sheikh.


We observed the Court building and gained knowledge about how many Court rooms and allied offices are there on First, Second, Third and Fourth floor besides well-equipped library. The ground floor is largely occupied by Advocate Bar, Public Prosecutor, E-Centre, Canteen etc. Then we started observing the Court and its proceedings, first we read the Board containing a list of Cases for the day which is placed on the wall outside the Courtroom.

After that when we were sitting inside the Courtroom, we observed proceedings and how the arguments were run for only one day i.e. 22nd March 2019. While listening to the Criminal matters, we obtained information about the Case type, Stage of case, Case Number, Warrant Case, & Procedure for applying for Anticipatory bail etc. We also understood how to take adjournment date and also learnt the stages of disposing matter of Criminal proceeding.

Our Batch Visited only on 22nd March 2019 and Rest of day the court was suspended for some time from 25th March 2019 to 30th March 2019 for Circuit Branch at Kolhapur District and Sessions Court located at Bavda. During this period no legal proceeding was going on. So, Students were not able to attend their Criminal Court Attendance due to some Holidays as well as Suspension of court. The Court attendance culminated with a group photo in front of the Kolhapur District and Sessions Court.

On the 4th of October 2022, we, the students, visited the District Legal Services Authority (DLSA), where the Secretary of DLSA and Senior Division Judge, Mr. Pritam Patil, provided us with a comprehensive overview of the operations of DLSA. The primary aim and function of DLSA are to provide free and competent legal aid, including counseling and legal advice, as well as free legal services for cases presented before courts and tribunals. Mr. Pritam Patil emphasized that DLSA primarily engages in coordination, mediation, arbitration, conciliation, and negotiation, with no involvement in judicial proceedings.

Additionally, DLSA organizes Lok Adalats four times a year to facilitate easy communication. Mr. Pritam Patil also informed us that in cases involving POCSO (Protection of Children from Sexual Offenses) violations, DLSA provides compensation to the victims. If the victim is a minor, DLSA creates a fixed deposit (FD) in the victim's name, allowing them to access the funds upon reaching the age of majority for future use. To date, DLSA has disbursed compensation ranging from 1.50 to 2 crore rupees to victims. This insightful session provided us with a comprehensive understanding of how the District Legal Services Authority operates.






