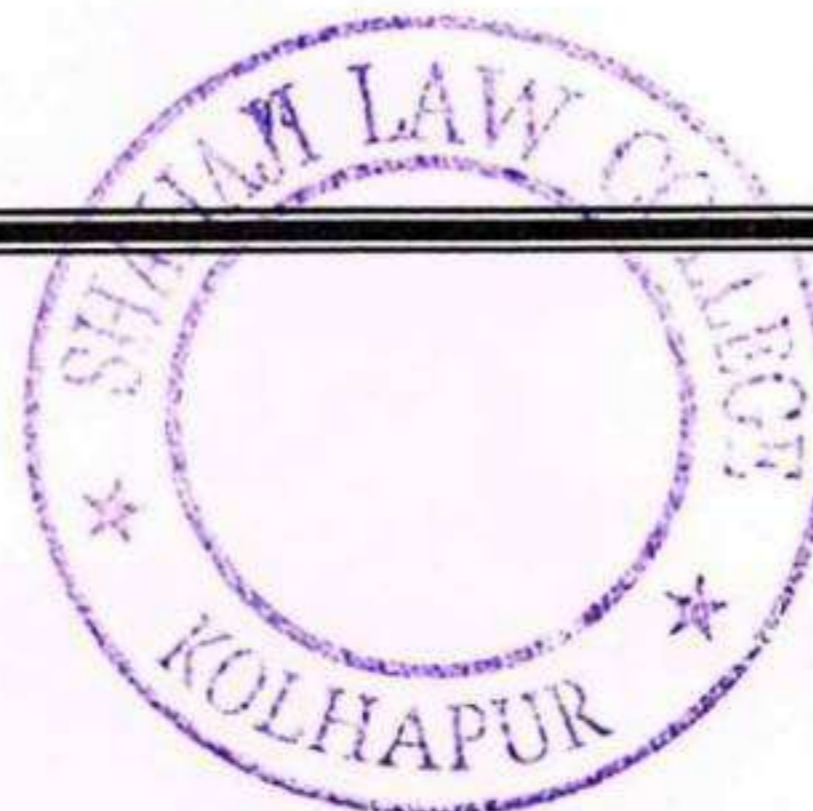

There, Adv. Shah Sir and Adv. Swapnil Chile Sir gave a guidance and information about the advocacy.

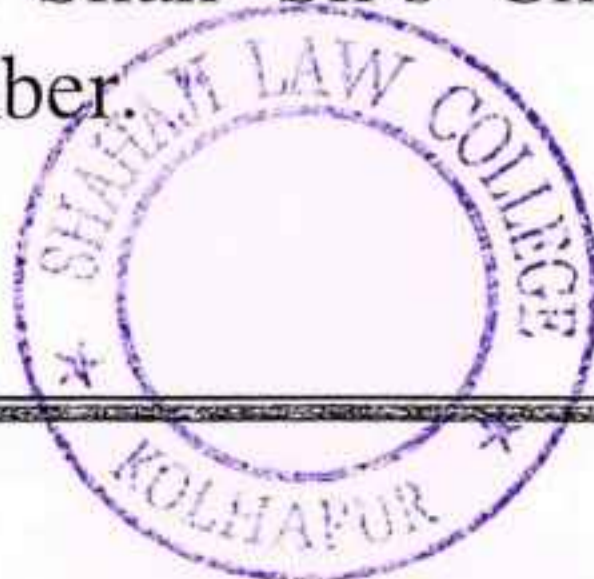
Sir told that the this is a profession and not a business or service. It should be judged on the basis of work, character, job satisfaction and not a wealth.

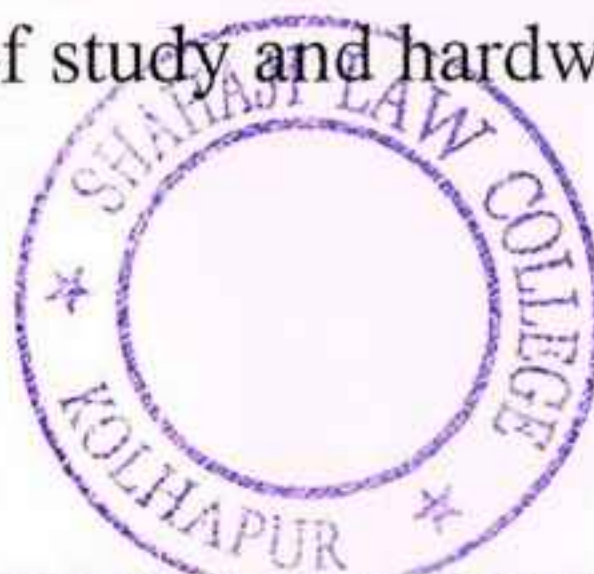
Firstly, Shri A. A. Laulkar Sir gave a speech on the topic of Moot Court.
