Mr. Waghwade Sir told us wide information of Bio-diversity Park and Babasaheb Ambedkar Nursery. He interact with students. He told that only forest plant species are available in Nursery. The state government provides funds time to time for preservation and protection of forest species. Bio-diversity Park situated in 58 hectares of land and Nursery in 9 hectares. In Previous Year 102 species of plants were in Nursery. Each plant has medicinal value. There are well, Borewell for water resource, irrigation. Nearly, 1,75,000 plants were sold in Year 2019. There are 11 labourers working in Bio-Diversity Park and Nursery. One of the labour named Tanaji gave the information and Demo of 'Mohagani' Plant. He worked in Nursery since 1987. He shared his experience with Mr. Dipak Khade Sir.
