mission of the College is "To provide quality legal education to the people of the region, empowering the students







with legal knowledge and transforming them ideal Indian Citizen in the context of global society."

We have tried to learn various drafting related with this field. We understand the legal aspects like position of tribunal which deals with such matters.

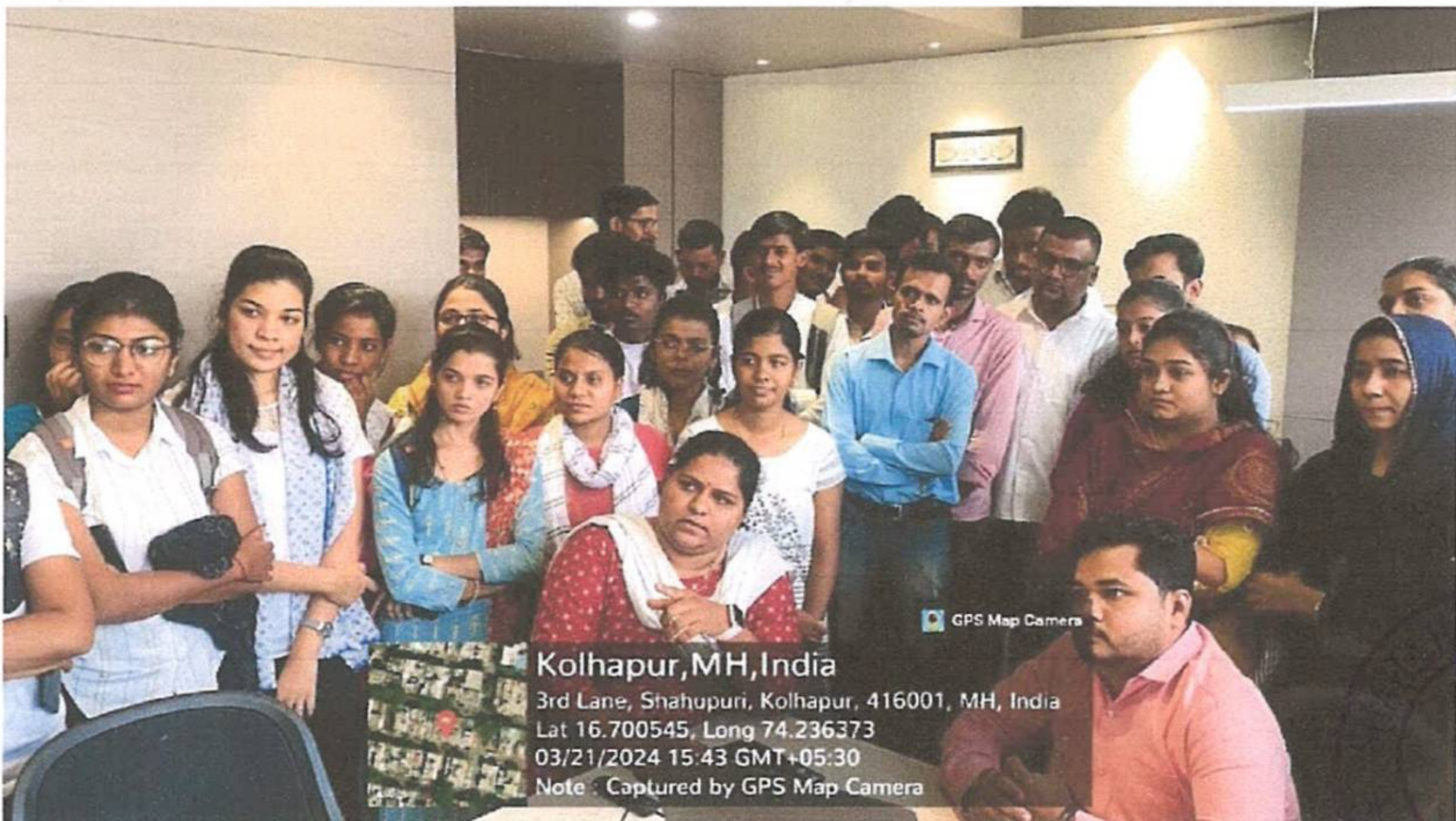

 - Observation during evidence and argument of his cases in the Court
 - Maintaining of diary for their attendance to the Chamber and Court
- provide Placements to passed out students of the First Party in his chamber with reasonable financial assistance

C. Implementation of the Objectives:




D. Benefits to the Parties:
