ANTI-RAGGING POLICY

Shahaji Law College, is a ragging free campus. The College maintains zero tolerance towards any such types of incidents. Ragging is STRICTLY prohibited in the college as per the "UCG Regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2009." Thus, Ragging is punishable activity in the college. At the time of admission the college provide link for the online submission of Anti - Ragging form to all the students. It is mandatory for the students to fill this form and adhered to all the rules and regulations provided for the Anti - Ragging at the Institutional level. Also a undertaking from Parent/Guardian of the student is taken regarding Anti - Ragging at the time of admission.

Ragging in any of the following forms -

- 1) **Physical Abuse** for eg. causing physical harm to the student or making someone cause physical harm to the student, forcing the student to perform dangerous life- threatening activities, forcing students to undress themselves or dress themselves in an inappropriate manner, drawing graffiti and making false representation, etc.
- 2) **Verbal Abuse** for eg. Name-shaming the student, using derogatory language against themselves or forcing them to use it against someone with reference to religion, caste, sex,

lifestyle and appearance of the person, making indirect or direct reference towards the sexuality of the student etc.

- 3) **Emotional or psychological Abuse** for eg, exercise of any undue control, manipulating the student in doing of certain activities directly or indirectly in view of their "supposedly" vested interest, causing fear psychosis in the minds of the student, etc.
- 4) **Sexual Abuse** for eg., causing the student to indulge into sexual activity, forcing the student to pass racial and sexual comments upon gender of the other students, drawing graffiti and making false representation, etc
- 5) **Digital Abuse** for eg threatening the student on online platforms, morphing the images of the students and circulating them widely on any social networking sites, spreading false propaganda against the student on the social networking sites, etc, will NOT be tolerated in any manner whatsoever and STRICT ACTION will be taken by the Anti-Ragging Committee and the College against the student indulging in or attempting to commit or found having committed any of such activities. The above forms of Ragging are inclusive in nature.

Ragging in all its forms is prohibited in the College Campus, including premises (academic, residential, sports, canteen, computer labs, library, staff room, college office), within the Campus or outside the Campus.

COMPLAINT MECHANISM -

Complaints against any student indulging in ragging should be immediately brought to the notice of the members of Anti-Ragging Committee. The Complaint can be

made either in writing or telephonically or in digital form - email or Whatsapp.

The Complaints can be made by the victim student or any friend of the victim student or the Class Representative of the Student or by any person having knowledge of the incident.

The Complaints made to be the Anti- Ragging Committee will be Confidential and not made public in any manner.

ACTION TAKEN AGAINST THE PERSON FOUND GUILTY -

Upon investigation and complete impartial scrutiny of the matter by the Anti-Ragging Committee, any student or group of students found guilty of ragging in the campus or even outside the campus shall be liable to one or more of the following punishments -

- 1) Debarring from appearing in any sessional test / University Examination.
- 2) Suspension from attending classes and academic privileges.
- 3) Withdrawing scholarships and other benefits.
- 4) Suspension from the college.
- 5) Cancellation of the admission.
- 6) Withholding the results.

However, if upon investigation it is found that the alleged complaint is frivolous, false and complete baseless, then action will be taken against the respective student.

ANTI - RAGGING COMMITTEE -

Anti-Ragging committee is formed As per Clause 6.3 (c), (d) and (e) the UGC Regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2009 in this institute. The Anti-Ragging Committee always tries to monitor and prevent ragging on college students. It is a committee working to keep the atmosphere in the college free from fear. This Committee is the supervisory and advisory committee in preserving a Culture of Ragging Free Environment in the college Campus.

OBJECT OF ANTI - RAGGING COMMITTEE -

- To maintain decorum in the College and bring a sense of responsibility amongst the students.
- To sensitise students about the evils of ragging and create awareness among the students.
- To initiate action against the erring student
- To address complaints about ragging as per the notification and circulars of the Central and State government and university procedures.
- To maintain records of the cases investigated and submit reports of the same annually.
- To be approachable and accessible to the support and needs of the students.

POLICY DOCUMENT ON STUDENT GRIEVANCE REDRESSAL

The students are the main stakeholder of the Shahaji Law College, Kolhapur. Student growth and development is the top priority of the institution. If a student has any grievance, it is taken up seriously by the concerned authorities. The institution has evolved an elaborate system of grievance redressal of the students. The Students' Grievance Redressal Committees is constituted at college level to deal with the grievances of the students.

Objectives of the Grievance Redressal Policy

- (a) To develop an organizational framework to resolve Grievances of Students.
- (b) To provide the students and staff access to immediate, hassle-free mechanism to have their Grievances redressed.
- (c) To enlighten the students and staff on their duties and responsibilities.
- (d) To establish structured interactions with Students and staff to elicit academic information, and administrative process of their expectations.



Definitional Clause

"Student" Means a person enrolled, or seeking admission to be enrolled, in any institution, to which these regulations apply, through any mode i.e., Formal/Open and Distance Learning (ODL)/ Online.

a) **"Act"** means the University Grants Commission Act, 1956 (3 of 1956)

b) **"aggrieved student"** means a student, who has any complaint in the matters relating to or connected with the grievance defined under these regulations

c) **"college"** means any institution, so defined in clause (b) of sub-section (1) of section 12A of the Act d) **"Commission"** means the University Grants Commission established under section 4 of the UGC Act, 1956

e) **"declared admission policy"** means such policy, including the process there under, for admission to a course or program of study as may be offered by the institution by publication in the prospectus of the institution

f) **"grievance"** means and includes complaint(s) made by an aggrieved student in respect of the following **"Students" Grievance Redressal Committee (SGRC)** means a committee constituted under these regulations at the level of an institution

- i. Admission contrary to merit determined
- ii. Irregularity in the process
- iii. Refusal to admit in accordance
- iv. Violation of any law in regard to reservation of seats
- v. Delay in payment of scholarships

2. Academic Integrity dispute
3. Course material
4. Class time table
5. Internal Assessment
6. Co-curricular activities

c) Grievance Against Faculty and staff

1. Academic delivery & quality
2. Classroom conduct
3. Regularity & punctuality
4. Any discrimination / victimization of students

d) Grievance related to examination

1. Registration / Re-registration / Student Records
2. End-Semester exam schedule
3. Evaluation of answer books
4. Re-checking/ Re- evaluation
5. De-barred / Year back cases
6. Delay in conducting examinations
7. Delay in the declaration of results

e) Grievance related to Amenities & Services

1. Common services
2. Extra-curricular facilities
3. Travel Concession
4. Identity Cards

Exclusions

The institution shall not entertain grievance related to:

1. Decisions of the Academic Council / Board of studies and other academic / administrative committees of the parent University and authorities.



2. Decisions with regard to award of scholarships / fee concessions / awards / medals declared by the Government and University.
3. Decisions made by college under the Discipline Rules and Misconduct.
4. Decisions of the CET cell during admission process.
5. Decisions of the competent authority on assessment and examination result

Grievance Redressal Mechanism

The Grievance Redressal Cell desires to promote and maintain a conducive and unprejudiced environment for its stakeholders. It attends to the grievances and complaints registered with regard to the activities of the Institution, and in particular, those made by students. The Cell ensures effective solution to the grievances, following the principles of natural justice. The Grievance and Redressal Cell enables the students to express their grievances by initiating and following the grievance procedure in accordance with the rules and regulations of the College.

The grievance redressal cell shall receive and redress grievances of students.

- I. The grievance shall be redressed depending upon the nature of grievance.
- II. The grievances are invited through online and offline mode.
- III. The college level counselling is offered where the matter can be resolved.
- IV. The grievances pertaining to amenity to be resolved by the class teacher.



- V. Academic, internal evaluation, administrative and other related grievances shall be redressed after receiving written and signed application.
- VI. The grievance redressal committee headed by the principal shall review the complaint and invites both parties for discussion.
- VII. Outcome of the discussion is communicated to concern parties.
- VIII. The grievances are redressed at the earliest by issuing warning letter, memo and reformation remedies.
- IX. Priority is given according to the urgency of the complaint.
- X. In all cases the aggrieved shall informed of measures implemented.
- XI. Check in the system is introduced to avoid repetition of the complaint.
- XII. All the grievances concerning to women harassment and ragging shall be dealt by the respective committees as per the prescribed procedures.

In pursuance of the Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act 2013 and the Rules framed there under, the College hereby adopts the following procedure for determining complaints filed to the Internal Complaints Committee (ICC) constituted under the Act. The procedure complies with the basic principles of natural justice and fair play and has to be adhered to in all complaints, though, in individual complaints, for reasons to be stated in writing, the ICC reserves the right to make exceptions to the procedure stated hereunder.

1. Any aggrieved student/woman may make, in writing, a complaint of sexual harassment at work place to the ICC, within a period of three months from the date of incident and in case of a series of incidents, within a period of three months from the date of last incident. 2 copies of a written complaint should be submitted to the Committee or any of its members along with list of witnesses and supporting documents. Additional documents and list of witnesses can be submitted to ICC at a later stage during the proceeding.

Provided that where such complaint cannot be made in writing, the Presiding Officer or any other member of the ICC shall render all reasonable assistance to the woman for making the complaint in writing.

Provided further that the ICC for the reasons to be recorded in writing, can extend the time limit not exceeding



three months, if it is satisfied that the circumstances were such which prevented the woman from filing a complaint within the said period.

2. Any complaint received by the members should be immediately forwarded to the Presiding Officer, and this must be notified to other committee members at the earliest and not later than 3 days and a meeting should be called for discussing the matter.

3. The Committee shall discuss and decide on its jurisdiction to deal with the case or reject the complaint prima facie and recommend to the Principal that no action is required to be taken in the matter.

4. Notice shall be issued to the respondent within 7 working days of receipt of the complaint and 10 working days shall be given for submission of reply (along with the list of witnesses and documents.)

5. The Committee will provide assistance to the aggrieved woman, if she so chooses, to file a police complaint in relation to an offence under Indian Penal Code.

6. The Committee may, before initiating an inquiry, at the request of the aggrieved woman, take steps to settle the matter between her and the respondent through conciliation.

7. No monetary settlement shall be made as the basis of conciliation. Where a settlement has been arrived at, the ICC shall record the settlement so arrived and forward the same to the employer for necessary compliance.

8. The Committee shall provide the copies of the settlement as recorded under (7) to the aggrieved woman and the respondent. Where a settlement is arrived at, no further inquiry shall be conducted by the ICC.



9. If conciliation is found to be not feasible, notice will be issued to both parties for hearing.

10. The Committee may direct the Registrar to ensure the safety and protection of the aggrieved woman if and when required.

11. As an interim measure, ICC may recommend



For staff

- a) the transfer of the aggrieved woman or the respondent to another section or Department as deemed fit by the Committee.
- b) grant leave to the aggrieved woman upto a period of three months or:
- c) restrain the respondent from exercising any administrative authority or supervision or academic evaluation of the aggrieved woman.
- d) grant such other relief to the aggrieved woman as the case may require.

For Student

- a) Protection and Support to the Student (Complainant)
- b) grant such other relief to the aggrieved student as the case may require.

12. The Committee shall proceed to make inquiry into the complaint in accordance with the provisions of the Act in case of student and in case of staff, service rules applicable to the respondent considering sexual harassment as misconduct

13. The Presiding Officer shall convene the first hearing of the enquiry. The respondent, the aggrieved student/ woman, and the witnesses shall be intimated at least 7 working days in advance in writing of the date, time and venue of the enquiry proceedings. The subsequent proceedings may be on a day to day basis, to be decided by ICC.

14. The Committee shall provide reasonable opportunity to the aggrieved student/woman and the respondent for presenting and defending her/his case.

15. The Committee may at any time during the enquiry proceedings, preclude the face-to-face examination of the respondent and the aggrieved student/woman and/or their witnesses



16. The Committee may call any person to appear as a witness if it is of the opinion that it shall be in the interest of justice. The aggrieved student/woman/respondent has to submit the written reply before the committee within the specified time given.

17. The Committee shall have the right to summon, as many times as required, the respondent, aggrieved student/woman and/or any witnesses for the purpose of supplementary testimony and/or clarifications.

18. The Committee shall have the power to summon any official papers or documents pertaining to the aggrieved student/woman as well as the respondent.

19. The past sexual history of the aggrieved student/woman shall not be probed into as such information shall be deemed irrelevant to a complaint of sexual harassment.

20. The Committee shall have the right to terminate the enquiry proceedings and to give an ex parte decision on the complaint, should the respondent fail, without valid ground, to be present for three consecutive hearings convened by the Presiding Officer.

21. The aggrieved student/woman and the respondent, or any one person on her/his behalf, shall have the right to examine written transcripts of the recordings with the exclusion of witnesses' names and identities. Any person nominated by the aggrieved student/woman and/or the respondent on her/his behalf shall be (only) either a student, or a member of the academic or non-teaching staff. No person who has been found guilty of sexual harassment shall be accepted as a nominee. The aggrieved student/woman/respondent should inform the Presiding Officer specifically if they wish to exercise this right. The Presiding Officer shall allow access to such documents on a specific date to be intimated at least two days in advance to each of the parties concerned. At no point in time, however, can the concerned parties take these documents outside the office.



22. The aggrieved student/woman and the respondent shall be responsible for presenting their witnesses before the Committee. However, if the Committee is convinced that the absence of either of the parties to the disputes is on valid grounds, the Committee shall adjourn that particular meeting of the Committee for a period not exceeding five days. The meeting so adjourned shall be conducted thereafter, even if the person concerned fails to appear for the said adjourned meeting without prior intimation/valid ground.

23. All proceedings of the ICC shall be recorded in writing. The record of the proceedings and the statement of witnesses shall be endorsed by the persons concerned as well as the committee members present in token of authenticity thereof. In case the minutes cannot be reduced in writing the same day, as audio recording of the proceedings may be made, and the written proceedings will be authenticated on a next available opportunity.

24. If the aggrieved student/woman desires to tender any documents by way of evidence, the Committee can supply true copies of such documents to the respondent. Similarly, if the respondent desires to tender any documents in evidence, the Committee shall supply true copies of such documents to the aggrieved student/woman.

25. In the event the Committee thinks that supplementary testimony is required, the Presiding Officer shall forward to the persons concerned a summary of the proceedings and allow for a time period of seven days to submit such testimony, in person or in writing, to the Committee.



26. The aggrieved student/woman and the respondent shall have the right of cross-examination of all witnesses. However such cross-examination shall be conducted in the form of written questions and responses via the Committee only. The respondent shall have no right to directly cross-examine the aggrieved student/woman or her witnesses.

27. The respondent/aggrieved student/woman may submit to the Committee, a written list of questions that he/she desires to pose to the aggrieved student/woman/witness. The Committee (ICC) shall retain the right to disallow any questions that it has reason to believe to be irrelevant, mischievous, slanderous, derogatory or gender-insensitive.

28. After concluding its investigation, the Committee shall submit a detailed reasoned report to the Principal.

29. If the Committee finds no merit in the allegations, it shall report to the Principal.

30. In the event the Committee finds that the allegation(s) against the respondent have been proved, it shall recommend the nature of action to be taken by the Principal. The following actions may be recommended:

31.

For Staff :

- a. A written apology
- b. Warning
- c. Reprimand or censure
- d. Withholding of promotion
- e. Withholding of pay rise or increments
- f. Undergoing a counselling session
- g. Carrying out of community service
- h. Terminating the respondent from service
- i. Any other punishment according to the service rules applicable to the respondent



For Student:

- a. A written apology
- b. Warning
- c. Student Rusticate
- d. Reprimand or censure
- e. Any other punishment according to the service rules applicable to the respondent

32. When the Committee arrives at the conclusion that the allegation against the respondent is malicious or the aggrieved woman or any other person making the complaint has made the complaint knowing it to be false or the aggrieved woman or any other person making the complaint has produced any forged or misleading document, it may recommend to the Principal to take action against such falsification.

33. Nothing precludes the Principal from taking cognizance of any new fact or evidence which may arise or be brought before it during the pendency of the inquiry proceedings or even after the communication of the findings to The Principal.

34. If the allegation(s) is/are proved against the respondent, the Committee may direct the Principal to ensure the payment of compensation to the aggrieved student/woman by the respondent. The determination of compensation to the aggrieved student/woman shall be decided based on the following facts:

- i. The mental trauma, pain, suffering and emotional distress caused to the aggrieved woman.
- ii. The loss of career opportunity due to the incident of sexual harassment.
- iii. Medical expenses incurred by the victim for physical or psychiatric treatment
- iv. The income and financial status of the respondent
- v. Feasibility of such payment in lumpsum or in installments

35. The Principal will file a compliance report to the Committee within 30 days of issuance of such recommendation.



36. ICC shall have the necessary powers to take suo motu notice of incidents of sexual harassment and/or gender injustice in the Institute campus and act against the same in such manner as it deems appropriate.

37. The identity of the aggrieved student/woman respondent, witnesses and proceedings of the Committee and its recommendations and the action taken by the Principal shall not be published, communicated or made known to the public, press or media in any manner and it will be outside the purview of the Right to Information Act, 2005.

38. No legal practitioner will be allowed to represent either the aggrieved student/woman or the respondent in proceedings before the Complaints Committee.

39. The Committee has the powers of a civil court [C.P.C. 1908] in the following cases

- i. Summoning and enforcing the attendance of any person related to the incident.
- ii. Requiring the discovery and production of any documents
- iii. Any other matter relating to the incident as decided by the Committee from time to time.

40. The aggrieved student/woman or respondent may prefer an appeal to the Internal Complaints committee, Shivaji University, Kolhapur.

1. लघु शीर्ष, अनुप्रयोग एवं समारम्भ:- (1) ये विनियम विश्वविद्यालय अनुदान आयोग (उच्चतर शैक्षिक संस्थानों में महिला कर्मचारियों एवं छात्रों के लैंगिक उत्पीड़न के निराकरण, निषेध एवं इसमें सुधार) विनियम, 2015 कहलाएंगे।
(2) ये विनियम भारत वर्ष में सभी उच्चतर शैक्षिक संस्थानों पर लागू होंगे।
(3) सरकारी राजपत्र में उनके प्रकाशन की तिथि से वे लागू माने जाएंगे।
2. परिभाषाएँ:- इन विनियमों में—बशर्ते विषयवस्तु के अन्तर्गत कुछ अन्यथा जरूरी है:-
(अ) "पीड़ित महिला" से अर्थ है किसी भी आयु वर्ग की एक ऐसी महिला—चाहे वह रोजगार में है या नहीं, किसी कार्य स्थल में कथित तौर से प्रतिवादी द्वारा कोई लैंगिक प्रताड़ना के कार्य का शिकार बनी है;
(ब) "अधिनियम" से अर्थ है कार्य स्थल में महिलाओं का लैंगिक उत्पीड़न (निराकरण, निषेध एवं समाधान) अधिनियम, 2013 (2013 का 14);
(स) "परिसर" का अर्थ उस स्थान अथवा भूमि से है जहाँ पर उच्चतर शैक्षिक संस्थान तथा इसकी संबद्ध संस्थागत सुविधाएँ जैसे पुस्तकालय, प्रयोगशालाएँ, लेक्चर हॉल, आवास, हॉल, शौचालय, छात्र केन्द्र, छात्रावास, भोजन कक्षों, स्टेडियम, वाहन पड़ाव स्थल, उपवनों जैसे स्थल तथा अन्य कुछ सुविधाएँ जैसे स्वास्थ्य केन्द्र, कैंटीन, बैंक पटल इत्यादि स्थित हैं तथा जिसमें छात्रों द्वारा उच्चशिक्षा के छात्र के रूप में दौरा किया जाता हो—जिस में वह परिवहन शामिल है जो उन्हें उस संस्थान से आने जान के लिए, उस संस्थान के अलावा क्षेत्रीय भ्रमण हेतु



संस्थान पर अध्ययनी अध्ययन भ्रमण, सैर-सफाई के लिए, लघु-अवधि वाली नियुक्तियों के लिए शिविरों के लिए उपयोग किए जा रहे स्थानों, सांस्कृतिक समारोहों, खेलकूद आयोजनों एवं एसी ही अन्य गतिविधियों जिनमें कोई व्यक्ति एक कर्मचारी अथवा उच्चतर शैक्षिक संस्थान के एक छात्र के रूप में भाग ले रहा है—यह समस्त उक्त परिन्तर में सम्मिलित है।

(डी) "आयोग" का अर्थ है विश्वविद्यालय अनुदान आयोग जो विश्वविद्यालय अनुदान आयोग अधिनियम 1956 (1956 का 3) के अनुच्छेद 4 के अन्तर्गत स्थापित है।

(ई) "अवृत्त व्यक्तियों" से अर्थ उन व्यक्तियों से है जो एक सुरक्षित गतिविधि में कार्यरत हैं जैसे कि किसी लैंगिक उत्पीड़न की शिकायत का दायर करना—अथवा वे ऐसे किसी व्यक्ति से घनिष्ठ रूप से सम्बद्ध हैं जो सुरक्षित गतिविधि में कार्यरत है तथा ऐसा व्यक्ति एक कर्मचारी हो सकता है अथवा उस पीड़ित व्यक्ति का एक कर्मचारी हो सकता है अथवा एक साथी छात्र अथवा अभिभावक हो सकता है।

(एफ) "कर्मचारी" का अर्थ उस व्यक्ति से है जिसे अधिनियम में परिभाषित किया गया है तथा इसमें इन विनियमों की दृष्टि से प्रशिक्षार्थी, शिक्षार्थी अथवा वे अन्य जिस नाम से भी जाने जाते हैं। आन्तरिक अध्ययन में लगे छात्र, स्वयंसेवक, अध्यापन-सहायक शोध-सहायक चाहे वे रोजगार में हैं अथवा नहीं, तथा संश्लेष अध्ययन में, परियोजनाओं लघु-स्तरीय के भ्रमण अथवा शिविरों में कार्यरत व्यक्तियों से है।

(जी) "कार्यकारी प्राधिकारी" से अर्थ है उच्चतर शैक्षिक संस्थान के प्रमुख कार्यकारी प्राधिकारी, चाहे जिस नाम से वे जाने जाते हैं— तथा जिस संस्थान में उच्चतर शैक्षिक संस्थान का सामान्य प्रशासन सम्मिलित है। सार्वजनिक रूप से निधि प्राप्त संस्थानों के लिए, कार्यकारी प्राधिकारी से अर्थ है अनुशासनात्मक प्राधिकारी जैसा कि कन्द्रीय नागरिक सेवाओं (यूनीफ़ॉर्म, नियन्त्रण एवं अपील) नियम तथा इसके समतुल्य नियमों में पराया गया है।

(एच) "उच्चतर शैक्षिक संस्थान" (एचई.आई.) से अर्थ है—एक विश्वविद्यालय जो अनुच्छेद 2 की धारा (ज) के अन्तर्गत अर्थों के अनुसार है, ऐसा एक महाविद्यालय जो अनुच्छेद 12 (ए) के उप-अनुच्छेद (1) की धारा (बी) के अर्थ के अनुसार है तथा एक ऐसा संस्थान जो मानित विश्वविद्यालय के रूप में विश्वविद्यालय अनुदान आयोग अधिनियम 1956 (1956 का 3) के अनुच्छेद 3 के अन्तर्गत है।

(आई) "आन्तरिक शिकायत समिति" (आई.सी.सी.) (इन्टरनल कम्प्लेन्ट्स कमिटी) से अर्थ है इन विनियमों के विनियम 4 के उप-विनियम (1) के अर्थ के अनुसार उच्चतर शैक्षिक संस्थान द्वारा गठित की जाने वाली आन्तरिक शिकायत समिति से है। यदि पक्षों से ही समान उद्देश्य वाला कोई निकाय सक्रिय है, (जैसे कि लैंगिक संवेदोकरण समिति जो लैंगिक उत्पीड़न संबंधी विवाद देखेगी (जी.एस.सी.ए.एस.एच.) ऐसे निकाय को आन्तरिक शिकायत समिति (आई.सी.सी.) के रूप में पुनर्गठित किया जाना चाहिए।

बशर्त, बाद वाले मामले में उच्चतर शैक्षिक संस्थान ऐसा सुनिश्चित करेगा कि इन विनियमों के अन्तर्गत आन्तरिक शिकायत केन्द्र के लिए ऐसे एक निकाय का गठन आवश्यक है। बशर्त कि ऐसा निकाय इन विनियमों के प्रावधानों द्वारा बाध्य होगा।

(जे) "संरक्षित गतिविधि" में ऐसी एक परम्परा, के प्रति तर्कपूर्ण विरोध शामिल है, जिसके बारे में ऐसा माना जाता है कि अपनी तरफ से अथवा कुछ दूसरे लोगों की तरफ से लैंगिक उत्पीड़न संबंधी कानूनों का उल्लंघन उस परम्परा के माध्यम से किया जा रहा है— जैसे कि लैंगिक उत्पीड़न मामलों की कार्रवाई में भागीदारी करना, किसी भी आन्तरिक जांच पड़ताल में अथवा कथित लैंगिक उत्पीड़न मामलों में सहयोग करना अथवा किसी बाहरी एजेंसी द्वारा की जा रही जांच पड़ताल में अथवा किसी मुकदमे में बतौर गवाह मौजूद रहना।

(के) "लैंगिक उत्पीड़न" का अर्थ है—

(i) ऐसा एक अनचाहा आचरण जिसमें छिपे रूप में लैंगिक भावनाएँ जो प्रत्यक्ष भी हो जाती हैं अथवा जो भावनाएँ अत्यन्त मजबूत होती, नीचतायुक्त होती हैं, अपमानजनक होती हैं अथवा एक प्रतिकूल और धमकी भरा वातावरण पैदा करती हैं अथवा वास्तविक अथवा धमकी भरे परिणामों द्वारा अधीनता की ओर प्रेरित करने वाली होती हैं तथा ऐसी भावनाओं में निम्नलिखित अवांछित काम या व्यवहारों में कोई भी एक या उससे अधिक या ये समस्त व्यवहार शामिल हैं (चाहे सीधे तौर से या छिपे तौर से) नामतः—

(अ) लैंगिक भावना से युक्त कोई भी अप्रिय शारीरिक, मौखिक अथवा गैर मौखिक के अतिरिक्त कोई आचरण

(ब) लैंगिक अनुग्रह या अनुसंधान करना

(स) लैंगिकतायुक्त टिप्पणी करना



case may be, once it is sought. The resolution of the conflict to the full satisfaction of the aggrieved party wherever possible, is preferred to purely punitive intervention.

(8) The identities of the aggrieved party or victim or the witness or the offender shall not be made public or kept in the public domain especially during the process of the inquiry.

9. **Interim redressal-**The HEI may,

- (a) transfer the complainant or the respondent to another section or department to minimise the risks involved in contact or interaction, if such a recommendation is made by the ICC;
- (b) grant leave to the aggrieved with full protection of status and benefits for a period up to three months;
- (c) restrain the respondent from reporting on or evaluating the work or performance or tests or examinations of the complainant;
- (d) ensure that offenders are warned to keep a distance from the aggrieved, and wherever necessary, if there is a definite threat, restrain their entry into the campus;
- (e) take strict measures to provide a conducive environment of safety and protection to the complainant against retaliation and victimisation as a consequence of making a complaint of sexual harassment.

10. **Punishment and compensation-** (1) Anyone found guilty of sexual harassment shall be punished in accordance with the service rules of the HEI, if the offender is an employee.

(2) Where the respondent is a student, depending upon the severity of the offence, the HEI may,-

- (a) withhold privileges of the student such as access to the library, auditoria, halls of residence, transportation, scholarships, allowances, and identity card;
 - (b) suspend or restrict entry into the campus for a specific period;
 - (c) expel and strike off name from the rolls of the institution, including denial of readmission, if the offence so warrants;
 - (d) award reformatory punishments like mandatory counselling and, or, performance of community services.
- (3) The aggrieved person is entitled to the payment of compensation. The HEI shall issue direction for payment of the compensation recommended by the ICC and accepted by the Executive Authority, which shall be recovered from the offender. The compensation payable shall be determined on the basis of-
- (a) mental trauma, pain, suffering and distress caused to the aggrieved person;
 - (b) the loss of career opportunity due to the incident of sexual harassment;
 - (c) the medical expenses incurred by the victim for physical, psychiatric treatment;
 - (d) the income and status of the alleged perpetrator and victim; and
 - (e) the feasibility of such payment in lump sum or in instalments.

11. **Action against frivolous complaint.**—To ensure that the provisions for the protection of employees and students from sexual harassment do not get misused, provisions against false or malicious complaints have to be made and publicised within all HEIs. If the ICC concludes that the allegations made were false, malicious or the complaint was made knowing it to be untrue, or forged or misleading information has been provided during the inquiry, the complainant shall be liable to be punished as per the provisions of sub-regulations (1) of regulations 10, if the complainant happens to be an employee and as per sub-regulation (2)



of that regulation, if the complainant happens to be a student. However, the mere inability to substantiate a complaint or provide adequate proof will not attract attention against the complainant. Malicious intent on the part of the complainant shall not be established without an inquiry, in accordance with the procedure prescribed, conducted before any action is recommended.

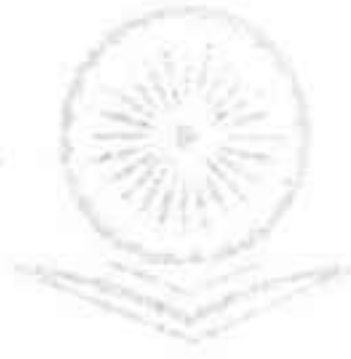
12. **Consequences of non-compliance.**—(1) The Commission shall, in respect of any institution that will fully contravenes or repeatedly fails to comply with the obligations and duties laid out for the prevention, prohibition and redressal of sexual harassment of employees and students, take one or more of the following actions after providing due notice: -

- (a) withdrawal of declaration of fitness to receive grants under section 12B of the University Grants Commission Act, 1956.
 - (b) removing the name of the university or college from the list maintained by the Commission under clause (f) of section 2 of said Act, 1956;
 - (c) withholding any grant allocated to the institution;
 - (d) declaring the institution ineligible for consideration for any assistance under any of the general or special assistance programmes of the Commission;
 - (e) informing the general public, including potential candidates for employment or admission, through a notice displayed prominently in the newspapers or other suitable media and posted on the website of the Commission, declaring that the institution does not provide for a zero tolerance policy against sexual harassment;
 - (f) recommending the affiliating university for withdrawal of affiliation, in case of a college;
 - (g) recommending the Central Government for withdrawal of declaration as an institution deemed to be university, in case of an institution deemed to be university;
 - (h) recommending the appropriate State Government for withdrawal of status as university in case of a university established or incorporated under a State Act.
 - (i) taking such other action within its powers as it may deem fit and impose such other penalties as may be provided in the University Grants Commission Act, 1956 for such duration of time till the institution complies with the provisions of these regulations.
- (2) No action shall be taken by the Commission under these regulations unless the Institution has been given an opportunity to explain its position and an opportunity of being heard has been provided to it.

NOTIFICATION

New Delhi, the __ October, 2018

In exercise of the power conferred under clause (g) of sub-section (1) of Section 26 of the University Grants Commission Act, 1956 (3 of 1956), and in supersession of the University Grants Commission (Grievance Redressal) Regulations, 2012, the University Grants Commission hereby makes the following regulations:

1. SHORT TITLE, APPLICATION AND COMMENCEMENT:

- a) These regulations shall be called as the University Grants Commission (Grievance Redressal of Students) Regulations, 2018.
- b) They shall apply to all HEIs, whether established or incorporated by or under a Central Act or a State Act, and every institution recognised by the University Grants Commission under clause (f) of Section 2 of the University Grants Commission Act, 1956 and to all institutions deemed to be a university declared as such under Section 3 of the said Act.
- c) They shall come into force from the date of their publication in the Official Gazette.

2. DEFINITION: IN THESE REGULATIONS, UNLESS THE CONTEXT OTHERWISE REQUIRES:

- (a) "Act" means the University Grants Commission Act, 1956 (3 of 1956);
- (b) "aggrieved student" means a student who has any complaint in the matters concerned with the grievances defined under these regulations, and includes a person seeking admission to any institution of higher education;
- (c) "college" means any institution, whether known as such or by any other name, which provides for a course of study for obtaining any



- (iv) An aggrieved person may appear either in person or be represented by such person as may be authorized to present his/her case.
- (v) The Grievances not resolved at the appropriate Grievance Redressal Committee(s) shall be referred to the Ombudsperson.
- (vi) The institution shall co-operate with the Ombudsperson or the Grievance Redressal Committee(s), as the case may be, in redressal of grievances and failure to do so may be reported by the Ombudsperson to the Vice Chancellor.
- (vii) On the conclusion of proceedings, the Ombudsperson shall pass such order, with reasons for such order, as may be deemed fit to redress the grievance and provide such relief as may be desirable to the affected party at issue, after giving due hearing to both the parties.
- (viii) Every order under the signature of the Ombudsperson shall be provided to the aggrieved person and the institution and shall be placed on the website of the institution.
- (ix) The institution shall comply with the recommendations of the Ombudsperson. Any recommendations of the Ombudsperson not complied with by the institution shall be reported by the Ombudsperson to the Commission.
- (x) In case of any false or frivolous complaint, the Ombudsperson may recommend appropriate action against the complainant.

8. INFORMATION REGARDING OMBUDSPERSON GRIEVANCE REDRESSAL COMMITTEE:

The institution shall provide detailed information regarding provisions of Grievance Redressal Committee(s) and Ombudsperson on their website and in their prospectus prominently.

9. CONSEQUENCES OF NON-COMPLIANCE:

The Commission shall in respect of any institution which willfully contravenes these regulations or repeatedly fails to comply with the recommendation of the Ombudsperson or the Grievance Redressal



Committee(s), as the case may be, may proceed to take one or more of the following actions, namely:

- (a) withdrawal of declaration of fitness to receive grants under section 12B of the Act;
- (b) withholding any grant allocated to the Institution;
- (c) declaring the institution ineligible for consideration for any assistance under any of the general or special assistance programs of the Commission;
- (d) informing the general public, including potential candidates for admission, through a notice displayed prominently in suitable media and posted on the website of the Commission, declaring that the institution does not possess the minimum standards for redressal of grievances;
- (e) recommend to the affiliating university for withdrawal of affiliation, in case of a college;
- (f) The Commission may take necessary and appropriate action as it may deemed fit, in case of an institution deemed to be university;
- (g) recommend to the concerned State Government for necessary and appropriate action, in case of a university established or incorporated under a State Act;
- (h) The Commission may take necessary and appropriate actions against any institution for non-compliance.

Provided that no action shall be taken by the Commission under this regulation unless the institution has been given an opportunity to explain its position and an opportunity of being heard has been provided to it.

(आठ) "लाभाचे पद" याचा अर्थ, लाभ किंवा आर्थिक लाभ मिळविण्याची क्षमता असलेले आणि ज्यास काही पगार, वतन, वित्तलब्धो, पारिश्रमिक किंवा पूरक भत्ता याव्यतिरिक्त इतर भत्ता संलग्न आहे असे पद, असा आहे ;

(9) The university or college or recognized institution, as the case may be, shall comply with the recommendations of the Ombudsperson. Any recommendations of the Ombudsperson not complied with by the university or college or recognized institution, as the case may be, shall be reported by the Ombudsperson to the University Grants Commission.

(10) In case of any false or frivolous complaint, the Ombudsperson may recommend appropriate action against the complainant.

9. Information Regarding Ombudsperson and Grievance Redressal Cell.—The university or college or recognized institution, as the case may be, shall provide detailed information regarding provisions of Grievance Redressal Cell(s) and Ombudsperson on their website and in their prospectus prominently.

10. Consequences of Non-Compliance.—The University Grants Commission, in respect of any university or college or recognized institution, as the case may be, which wilfully contravenes this Statute or repeatedly fails to comply with the recommendation of the Ombudsperson or the Grievance Redressal Cell(s), as the case may be, may proceed to take one or more of the following actions, namely:—

(1) Withdrawal of declaration of fitness to receive grants under section 12B of the University Grants Commission Act, 1956 (3 of 1956);

(2) Withholding any grant allocated to the university or college or recognized institution, as the case may be;

(3) Declaring the university or college or recognized institution, as the case may be, ineligible for consideration for any assistance under any of the general or special assistance programmes of the University Grants Commission;

(4) Informing the general public, including potential candidates for admission, through a notice displayed prominently in suitable media and posted on the website of the University Grants Commission, declaring that the university or college or recognized institution, as the case may be, does not possess the minimum standards for redressal of grievances;

(5) Recommend to the affiliating university for withdrawal of affiliation, in case of a college and withdrawal of recognition in case of recognized institution;

(6) Recommend to the concerned State Government for necessary and appropriate action, in case of a university;

(7) Take necessary and appropriate actions against any university or college or recognized institution, as the case may be, for non-compliance :

Provided that no action shall be taken by the University Grants Commission unless the university or college or recognized institution, as the case may be, has been given an opportunity to explain its position and an opportunity of being heard has been provided to it.

Dated 17th June, 2009.

PREAMBLE.

In view of the directions of the Hon'ble Supreme Court in the matter of "University of Kerala v/s. Council, Principals, Colleges and others" in SLP no. 24295 of 2006 dated 16.05.2007 and that dated 8.05.2009 in Civil Appeal number 887 of 2009, and in consideration of the determination of the Central Government and the University Grants Commission to prohibit, prevent and eliminate the scourge of ragging including any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other student, or indulging in rowdy or indisciplined activities by any student or students which causes or is likely to cause annoyance, hardship or psychological harm or to raise fear or apprehension thereof in any fresher or any other student or asking any student to do any act which such student will not in the ordinary course do and which has the effect of causing or generating a sense of shame, or torment or embarrassment so as to adversely affect the physique or psyche of such fresher or any other student, with or without an intent to derive a sadistic pleasure or showing off power, authority or superiority by a student over any fresher or any other student, in all higher education institutions in the country, and thereby, to provide for the healthy development, physically and psychologically, of all students, the University Grants Commission, in consultation with the Councils, brings forth this Regulation.

In exercise of the powers conferred by Clause (g) of sub-section (1) of Section 26 of the University Grants Commission Act, 1956, the University Grants Commission hereby makes the following Regulations, namely;

6) I hereby declare that my ward has not been expelled or debarred from admission in any institution in the country on account of being found guilty of, abetting or being part of a conspiracy to promote, ragging; and further affirm that, in case the declaration is found to be untrue, the admission of my ward is liable to be cancelled.

ONE DAY NATIONAL SEMINAR ON TRAFFICKING OF WOMEN: CAUSES, CONSEQUENCES AND SOCIO-LEGAL RESPONSES SPONSORED BY NATIONAL COMMISSION FOR WOMEN

Nearly 240 participants including from Karnataka, Andhra Pradesh, Delhi, Goa, Chattisgad, Madhya Pradesh were participated

ABOUT THE SEMINAR

Trafficking of women for the purpose of sexual exploitation, prostitution, forced labour, slavery and servitude is a worldwide phenomenon unfolding by leaps and bounds every day. Many International Conventions supported by National Legislations and Policies are put in place by the national and international communities to curb this ever-growing menace. However, the ground realities narrate different stories. Of the agencies tasked to ameliorate the conditions of women, National Commission for Women (NCW) is a front runner. Having understood that the lack of sensitization among the stakeholders about the phenomenon of trafficking has resulted in perpetuation of this crime, the NCW has encouraged the institutions to shoulder their responsibility in disseminating the presence and importance of legal framework and rehabilitative schemes for the victims of the trafficking. The present seminar is one of such joint ventures between National Commission for Women and Shahaji Law College, Kolhapur.

OBJECTIVES OF THE SEMINAR

The seminar is intended to achieve the following objectives

1. To trace out the causes of women trafficking from the perspectives of law, social sciences and perceived social norms.
2. To understand the trauma, helplessness and loneliness of the victims of women trafficking.
3. To unearth the investigation predicament of police personnel in handling women trafficking.
4. To assess the adequacy of legal framework in India and the responsive schemes.
5. To review the constructive role played by National Commission for Women, other statutory bodies and NGOs in prevention of women trafficking.
6. To unfold the constructive interpretations by judiciary in rehabilitation of victims of women trafficking.
7. To underscore the constructive and conjunctive roles to be played by the society, police, judiciary and family in the prevention of trafficking of women.

Rapporteur Report of One Day National Seminar on Trafficking of Women: Causes, Consequences and Socio-Legal Responses

A One Day National Seminar on Trafficking of Women: Causes, Consequences and Socio-Legal Responses was organised on 30th March 2019 by Shahaji Law College, Kolhapur, Maharashtra. 240 faculty, research scholars and students registered for the Seminar. The seminar had 7 sessions in all, which include:

1. Inaugural Session
2. Two Plenary Session
3. Three Simultaneously conducted Technical Session
4. Valedictory Session

Session I: Inaugural Session

The Inaugural Session started at 10.30 a.m. on 30th March 2019.

The Inaugural session was chaired by Hon'ble Mrs. Rajanitai Magdum, President, Council of Education. The Seminar was inaugurated at the hands of Prof. (Dr.) Devanand Shinde, Hon'ble Vice-Chancellor, Shivaji University, Kolhapur. Hon'ble Shri. Umeshchandra More, Secretary, District Legal Services Authority was the Keynote Speaker. Hon'ble Shri. Prasad Kamat, Vice-President, Council of Education, Adv. V.N.

Patil, Member, Council of Education were the guests of Honour. Director of the Seminar, Dr. R. Narayana, Principal, Shahaji Law College and Dr. Praveen Patil, Convener of the Seminar were also present on the dais.

After the formal inauguration of the National seminar, Principal Dr. R. Narayana welcomed the dignitaries and gave a brief introduction of the college. Dr. Praveen Patil then elaborated on the theme of the seminar and the reason at having picked such a sensitive subject.

In his inaugural address, Dr. Devanand Shinde put before the audience the statistics regarding women trafficking at the global level and in different scenarios published by the UN. He was vocal about the need to address the issue on an emergency level. He also expressed the necessity of the Government agencies to take stern steps to put a stop to the menace. The keynote address was delivered by Shri. Umeshchandra More, Secretary of District Legal Services Authority of Kolhapur. In his address, Shri. More put forth his

experiences while working for the rehabilitation of trafficked women. He also elaborated on the need to address the issue transgenders and children who get caught in trafficking. He quoted several cases and judgments like the case of 'Prajwal', in his speech.

In her Presidential address, Hon'ble Rajanitai Magdum congratulated her college team for organizing a national seminar on such a sensitive and burning issue. She expressed hope that the seminar will not remain only a theoretical exercise and would motivate the participants to carry the message of the significance to put an end to this practice to the society at large. At the end of the inaugural session Dr. Praveen Patil proposed the vote of thanks.

Session II: Plenary Session I

In the first Plenary Session, Dr. Santosh Shaha took the participants through the Constitutional provisions regarding protection of Women from

trafficking. He further spoke on The Trafficking of Persons (Prevention, Protection and Rehabilitation) Bill, 2018. He discussed in great detail the pros and cons of the bill. He pointed out the changes in the present bill vis-à-vis the Immoral Traffic (Prevention) Act, 1986.

In her comments as the Chairperson of the session, Dr. Mangala Patil provided an overview of the views of Dr. Shaha. She also put forth the social implications of the immoral practice of women trafficking. Her suggestions included the active participation of the people to get rid of the menace of trafficking.

At the end of the session, Dr. M. C. Sheikh expressed vote of thanks to the resource person, chairperson and the participants.

Ms. Tejaswi Sevekari, in the second plenary session, presented to the audience the activities of her organization. Saheli Sangh works for the rehabilitation of women who have been freed from bondage



of trafficking. She also put forth her views regarding the legal provisions in the act regarding women trafficking. She pointed out the gaps, in not only the provisions of the law but also in its practice. Ms. Sevekari was of the opinion that the lack of information and malpractices in the police departments has led to the faulty handling of the issue. She expressed the hope that the government would look into the shortcomings of its acts and provisions.

Mrs. Sadhana Zadbuke, a well-known and experienced social activist in the state of Maharashtra, and also a participant at the seminar presented her views in this session. She has worked with Government of Maharashtra and on many committees for the protection and rehabilitation of women caught in trafficking. She also spoke on evil social practices like devdasis which lead to trafficking. Mrs. Zadbuke presented her experiences, to the participants, while working in for the rehabilitation of these women.

In the chairperson evaluation, Prin. Uday Sawant spoke in great appreciation of the work being carried out by the resource person. He felt that Ms. Sevekari was carrying out the most difficult task. He felt instead of judging the success or failure of Saheli Sangh, the need of the hour was to

join hands with their activities.

The session ended with the vote of thanks expressed by the coordinator Dr. Savita Rasam.
