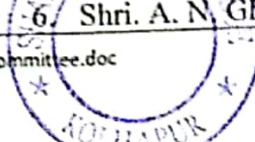

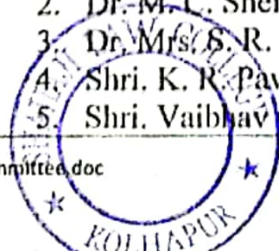

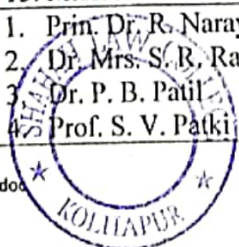
Various committees were constituted in every institution under the chairmanship of the Head of the Institution with heads of important academic and administration units and a few teaching and a few distinguished educationalists and resp

A One Day National Seminar on Trafficking of Women: Causes, Consequences and Socio-Legal Responses was organised on 30<sup>th</sup> March 2019 by Shahaji Law College, Kolhapur, Maharashtra. Faculty, research scholars and students registered for the Seminar. The seminar had 7 sessions in all, which include

1. Inaugural Session
2. Two Plenary Session
3. Three Simultaneously conducted Technical Session
4. Valedictory Session

### Session I: Inaugural Session

The Inaugural Session started at 10.30 a.m. on 30<sup>th</sup> March 2019.

The Inaugural session was chaired by Hon'ble Mrs. Rajanitai Magdum, President, Council of Education. The Seminar was inaugurated at the hands of Prof. (Dr.) Devanand Shinde, Hon'ble Vice-Chancellor, Shivaji University, Kolhapur. Hon'ble Shri. **Rapporteur Report of One Day National Webinar on Migrant Workers and Labour  
Laws: Identifying Gaps and Exploring Legal Remedies on 23<sup>rd</sup> December 2020**

A One Day National Webinar on '*Migrant Workers and Labour Laws: Identifying Gaps and Exploring Legal Remedies*' was organised in Council of Education's Shahaji Law College on 23<sup>rd</sup> December 2020, the 22<sup>nd</sup> Death Anniversary of the Founding Father of the Institution Deshbhakt Dr. Ratnappanna Kumbhar. The National Webinar was funded by the National Commission for Women.

**Inaugural Session:**

The National Webinar began with an introduction of the theme of the Webinar by Principal Dr. R. Narayana. Dr. Narayana thanked the National Commission for Women for providing funds to conduct the webinar on such a timely and pressing issue. Dr. Vishwanath Magdum, Member, Council of Education also addressed the participants of the seminar. He highlighted the immense contribution of Dr. Ratnappanna Kumbhar to alleviate the position of the working class and also his contribution to the making of the Indian Constitution. He wished a grand success for the National Webinar. The Key note Speaker for the Inaugural session was Prof. (Dr.) Ishwar Bhat, Vice Chancellor of the Karnataka Law University, Dharwad. The key note Speaker was introduced by Dr. Suchita Suragihalli. In his key note address Prof. Bhat covered a number of Legislations, International Conventions and policies for the migrant workers in context of the Women migrant workers. He highlighted the various benefits that can be given to women migrant workers even if they are appointed on a temporary basis. He pointed out that the labour market, prominently that of the migrant workers is gendered in the sense that women have to face discrimination, exploitation and apathy. Sir drew attention to the United Nation conventions meant especially for the migrant workers which the nations should adopt and implement as a moral responsibility. He argued that the scope left for interpretation of laws should not result in discrimination against women but rather in realization of Gender Equality. The vote of thanks for the inaugural session was expressed by Dr. Suchita Suragihalli.

### 1<sup>st</sup> Technical Session:

The topic for the 1<sup>st</sup> Technical session was '*Role of Policies and Legislation: viz-a-viz Migrant Women Workers*'. The Resource Person for the first Technical Session was Hon. Pankaj Deshpande, Secretary, District Legal Service Authority, Kolhapur. Dr. M. C. Sheikh faculty member of Shahaji Law College, introduced the Resource Person. Hon. Deshpande at the very outset made it clear that the while looking for solutions to the issue of rights of migrant women workers, we should have a right-based approach rather than a charity-based one. It should be free of traditional biases. He highlighted the effect of manual labour on the health and shelter of women. Deshpande Sir took an overview of the Constitutional basis of legislation for migrant women worker in Fundamental rights and Directive Principles of State Policy. He emphasized that there can be no excuse for not converting the provisions into a law. He lamented on the fact that lack of data and statistics regarding these workers also results in lack of effective measures to overcome the issue. He concluded by stating that migration is going to be present forever, so the policymakers need to change their mindset and come up with action oriented plans to beat the tragic and hapless situation of the migrant women workers.

### 2<sup>nd</sup> Technical Session:

The topic of the 2<sup>nd</sup> Technical Session was '*Implementation of Labour Laws to Migrant Women Workers in India*'. The resource Person for the session was Senior Adv. Dr. Santosh Shaha. Dr. Savita Rasam, Faculty of Shahaji Law College introduced the resource person. Adv. Santosh Shaha took an overview of the Directive Principles of State Policy in the Indian Constitution from Article 39 to 43 to underline the responsibilities of the State viz-a-viz its responsibility towards the migrant workers and women in particular. Sir also examined the provisions of labour laws like, Interstate Migrant Workman Registration Act 1979, the Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act 2013 and the yet to be enacted Occupational Safety Healthy Working Conditions Code 2019. The Interstate Migrant Workman Registration Act, Adv. Shaha said also include the application of other legislations like Workman's Compensation Act 1923, Payment of Wages Act 1936, Industrial Dispute Act 1947 and many acts which provide relief like The Maternity Benefit Act 1961. But the lack of awareness among the workers keeps them bereft of the benefits of these acts. Shaha sir also examined Case Laws like Harsh Mander vs Union of India and Alakh Alok Srivastava vs Union of India in which the SC



came down heavily on the Government regarding granting of Minimum Wages, basic necessities and medical facilities to be provided to the workers. Dr. M. C. Sheikh delivered the vote of thanks for the session.

### 3<sup>rd</sup> Technical Session:

The topic of the 3<sup>rd</sup> Technical Session was '*Migration a Challenge to Women Rights: Social Issues and Politico-economic Redressal*'. The Resource person for the 3<sup>rd</sup> Technical session was Dr. B. S. Patil, Sлагаocar Law College, Goa. Prof. Suhas Patki, Faculty of Shahaji Law College introduced the Resource Person. Through 11-points relating to the topic Dr. B. S. Patil made an exhaustive and rigorous discussion regarding the plight of the migrant women workers. He referred to migration as double-edged sword which on the one hand brought economic growth in its host land but on the other hand changed its the cultural demography. He made a distinction between internal and intra migration in terms of its nature, its push and pull factor and predictability. Dr. Patil is of the opinion that a feminisation of migration has taken place and its study in the context of share in employment, wages, flexibility of nature of work is imperative in present times. He identified the constraints of women migration i.e., manipulation of employment agencies, sexual exploitation, withholding wages, lack of healthcare etc. Dr. Patil recommended that the benefits of migration need to be highlighted to increase public awareness, pan-India migration studies need to be conducted, women returning home need to be socially and mentally supported etc.

At the end the Dr. Praveen Patil, Convenor of the One Day National Webinar on Migrant Workers and Labour Laws: Identifying Gaps and Exploring Legal Remedies delivered the vote of thanks to the Directors of the Council of Education, Principal, Faculty members, non-teaching staff, students and participants. The webinar was anchored by Dr. Suchita Suragihalli and Dr. Asmita Patil.
