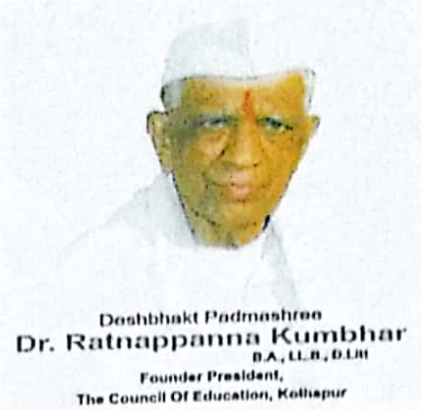
COLLEGE - BRIEF HISTORY

Shahaji Law College is one of the Premier law college imparting legal education since 1933.

His Highness, the Late Shri Rajaram Chatrapati Maharaja of Kolhapur, who was always very keen about legal education constituted a committee in December 1932 headed by Rao Bahadur A.B. Chougule the then Chief Justice of Kolhapur State. By notification 52 of 1933 in the State Gazette declared that " **The Council of Legal Education, Kolhapur.**" a body corporate consisting of seven ex-officio members formed to manage the Law College on 17th June, 1933.

The first Principal of the college Shri.S.K.Kelavkar, Barrister-at-Law and His Highness Major Sir Shri. Chatrapati Shahaji Maharaj and the founder President of the Council of the Education Shri Deshbhakta Padmashri Ratnappanna Kumbhar were first students of this college.

The College was formely inaugurated on 2nd November 1933 at the hands of Sir Fredric Sykes, the then Governor of Bombay and named as 'Sykes Law College' Kolhapur. After the merger with Bombay State the College was run by the Government for two years then it declared Government intends to close the college. On 17 th Feb. 1951 under the able leadership of Anna the council of education was established and the college renamed as Shahaji Law College Kolhapur. Since then the Council of Education is administer efficiently with dynamism and in the perspectives of Anna's vision.
