College is one of the first colleges in India for imparting legal education since 1933.

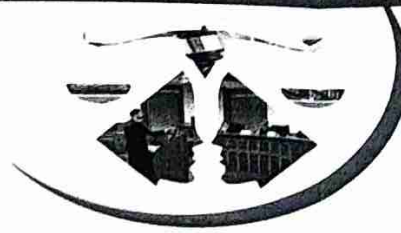

SANCTION ORDER

1.
