Dajipur Wildlife Sanctuary, now known as Radhanagari Wildlife Sanctuary. It was declared as first Wildlife Sanctuary in 1971 within Maharashtra. It is a natural World Heritage site since 2012 located at Kolhapur district. It lies at the southern end of Sahyadri hills. This Dajipur Wildlife Sanctuary is popularly known as the "Bison Sanctuary".

Under the co-ordination of Prof. Dr. M.C. Sheikh sir and Prof. Dr. S.R. Patil ma'am this 'Environmental Study Tour' was organised for the students who participated in 'Tree Plantation Drive' and winners of 'Oration Competition' under 'Environment Law', at Dajipur, Puntambur.

For this study tour, we submitted the letter to the 'Chief Conservator of Forests' for permission to visit and to provide us transportation facility, and they permitted us to visit there and also provided us bus for transportation.

Our journey towards Radhanagari Wildlife Sanctuary started at 7.00 am. with 11 students and 4 teachers i.e. our Principal Dr. R. Narasir, Prof. Dr. M.C. Sheikh sir, Prof. Dr. S. Patil ma'am and Librarian Kailash Pawar sir. Firstly we visited the Butterfly Garden (Fulphani Garden). In this garden Mr. Presh Ombade, a member of Bison Nature Club gave us a lot of information about Dajipur Wildlife Sanctuary. As per the information given by him, Dajipur Wildlife Sanctuary has covered an area of

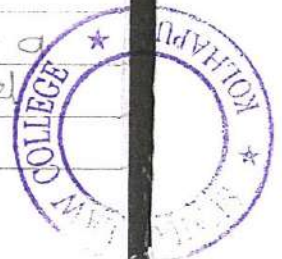


is allowed to go there. There are about 800 to 1000 Bison, for which this wildlife sanctuary is famous. There are other type of diversities also. This sanctuary is home of a wide variety of animals, birds, reptiles and butterflies. There are 131 species of butterflies have been recorded in this wildlife sanctuary. out of these 41 species are found in the Butterfly Garden. There are various types of trees in this Butterfly Garden such as Samaj flower, Badak flower, Haladi-kunda, ~~in~~ khukhula, etc.

After this we visited 'Elephant Palace' (Hattimahad), Hattimahad is a building built by Shahu Maharaj where Elephants were kept. Then we also visited to Devrai temple as well as Konkandarshan point where boundary of Kolhapur District ends and of Sindhudurg District starts.

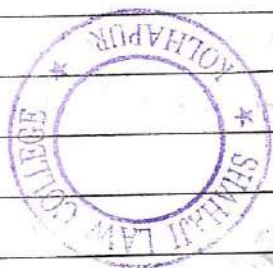
We then visited the 'National Information Centre' of Rajapur Wildlife Sanctuary. Here we got detailed information about all animals, birds, trees etc which found in this sanctuary. The Radhanagari Wildlife sanctuary contains tropical evergreen forests. 425 species of plants have been recorded in the sanctuary. sanctuary also contains 47 species of Mammals, 59 species of reptiles, 264 species of birds. To see this information centre we travelled there by cycle.

After that we had lunch near a pond and after lunch we visited

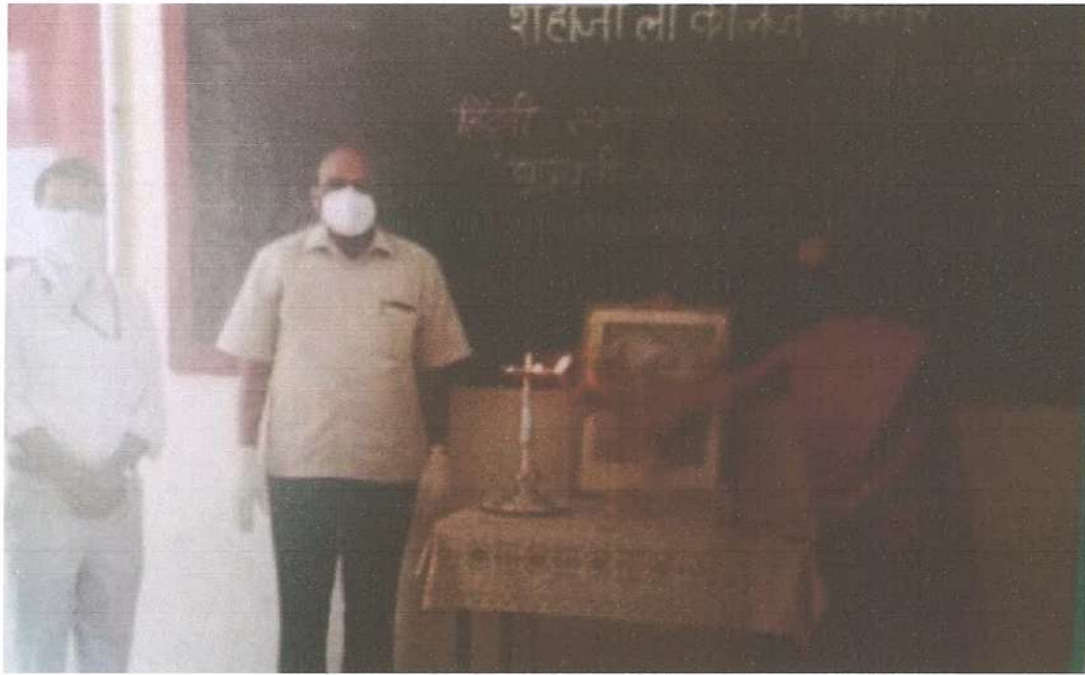



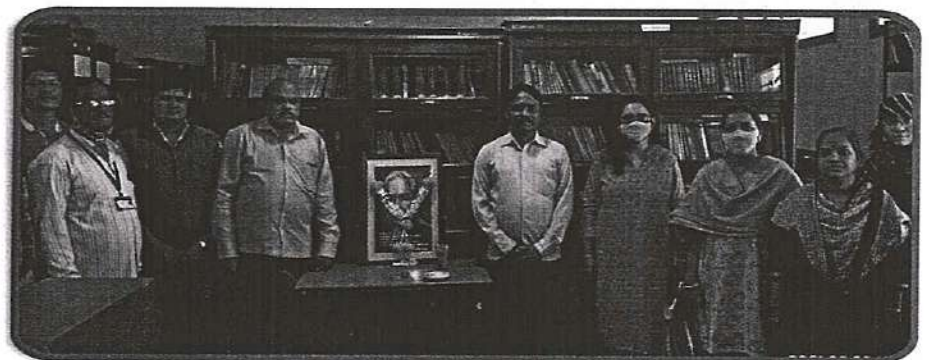
