- Membership fee of professional bodies


PROCEDURE FOR APPLICATION AND APPROVAL

To avail the financial support the faculty needs to follow the procedure of application given below

1. Teachers who register for seminars, conferences, workshops need to make an application to the principal about his participation and the respective fee of the registration. After receiving the approval from principal, the funds are released by the Account section of the college.

2. There is a provision of reimbursement of registration fee by college, if the fee is paid by the teachers in the first place.
3. The college maintain record of receipt of registration fee and a copy of attendance certificate
4. The college provides the membership fee for the professional bodies of the teachers who prefer to enroll. The records of the same are maintained by Account section.
5. For the professional development programme the college sanctions the course fee to the faculty organized by other institution. The records of the registration receipts have been maintained by the Account Section.
