Dr. Ratnappa Bharammappa Kumbhar also called Deshbhakt Ratnappa Kumbhar was a freedom fighter from Ichalkarnji who actively participated in the Indian Independence Movement. He was one of the members to sign the final draft of the Constitution of India along with Dr. B.R. Ambedkar. He received Padmashri Award in 1985 (Social Work).

He was Member of the Parliament, Member of Legislative Council, Minister of Food and Civil Supplies and also Home Minister of Maharashtra Government. He was the speaker of the Maharashtra State Legislative Assembly in (1995). Dr.Ratanppa Kumbhar was born in a poor Khumbhar Family at Nimshirgaon village in Shirol tehsil. He was influenced by his father Bharammappa Kumbhar’s intelligence, selfless attitude, sympathy towards needy and devotion towards task undertaken. His father encouraged him to acquire higher education. He completed his B.A. (English) from Rajaram College, Kolhapur and later acquired a law degree. For his social and political contribution he was honored with D.Lit by Pune University.

During his youth he was very interested in Political and social work. He established Prajaparishad in 15th Feb, 1938 against the local princely state rulers. He actively participated in the freedom movement and went underground for about 6 years. For his long devotion to the Independence Movement he was called Deshbhakt (Patriot) Ratanppa Kumbhar. For the welfare of farmers and prosperity of the people in his constituency he undertook various schemes and established various organizations and managed them successfully—

LL.M. R.1: Implementation of Regulations & guidelines:

The Regulations and guidelines shall be implemented as mentioned below-

LL.M. Part-1, Semester I & II from Academic year 2019-20

LL.M. Part II, Semester III & IV from Academic year 2020-21

LL.M. R.2: LL.M. Course and Duration:

- a) The LL.M. Programme shall be a full time course both at University Departments and P.G. Centres at Law Colleges affiliated to Shivaji University, Kolhapur. The duration of the course shall be of two years with four semesters. There shall be a University Examination at the end of each Semester. Each Semester shall have minimum 15 weeks of teaching, excluding the vacation and examination.
- b) The LL.M. programme shall be offered in the specialised course: **Business Law**
- c) Intake Capacity: Intake capacity for the course shall be as per the sanctioned seats approved by Shivaji University, Kolhapur.

LL.M.R.3: Medium of Course:

The medium of course and examinations shall be in English.

LL.M. R.4: Admission and Eligibility:

- a) Admission to Two Years LL.M. program will be on the basis of merit subject to intake capacity.
- b) The student who has obtained LL.B. Degree under Three Year or Five Year Law Courses under this University or a degree of any other University recognized as equivalent to be LL.B. Degree of this University shall be eligible for admission.
- c) The minimum percentage of marks not below 50% of the total marks in case of General Category Applicants, 45% for OBC category and 40% of the total marks in case of SC/ST Applicants. The reservation policy shall be subject to rules and regulations of Government of Maharashtra from time to time.
- d) The Merit List shall be prepared, based on the highest score obtained by the candidate at the 5 years or 3 years LL.B. Programme.
- e) Admissions will be subject to reservation policy and rules prescribed by the Maharashtra State Government and the Shivaji University from time to time.

• LIBRARY LENDING RULES

1. Books are issued and reserved as per demand.
2. Only one book will be issued for a week on the production of borrower's card.
3. The book may be retained for prescribed period of time unless recalled by the librarian.
4. A fine of Rs. 1 per day will be charged after the due date.
5. The loss or damage to the book shall have to be made good by the borrower.
6. The borrower should bring his identity card with him & produced it on demand.

• LIBRARY RULES

1. Books will be issued to the members only on the production of Barcoded Identity Card.
2. Students of this institution with identity card only are allowed to use the library facilities.
3. No member is allowed to enter the library with personal belonging or books. However, pain papers or notebook are allowed inside the reading room.
4. Members must scan their Barcoded Identity Card while entering to the Library of Reading Room.
5. Barcoded Identity Card if lost, should immediately be reported to the Librarian. Duplicated ID will be issued after the payment of Rs. 50/-.
6. No dues certificated will be issued by the librarian when a reader ceases to be a member and return all books.
7. Books arranged in the racks should not be disturbed. They should trace them in an orderly way.
8. Those who violates the rules and regulations of the library will not be allowed to use the library and disciplinary action will be initiated against them by the authorities.
9. Damage / rare books and the books which are 25 years old will not be issued.
10. Reference and Multivolume books and periodicals ae not normally lent.
11. Regular students return their books within time, otherwise a fine of Rs. 1/- per day will be charged after the due date.

• BOOK BANK SCHEME

State Government Social Welfare Department provides the fund for purchasing the books under the book bank scheme. This facility is available only for SC and ST category students. 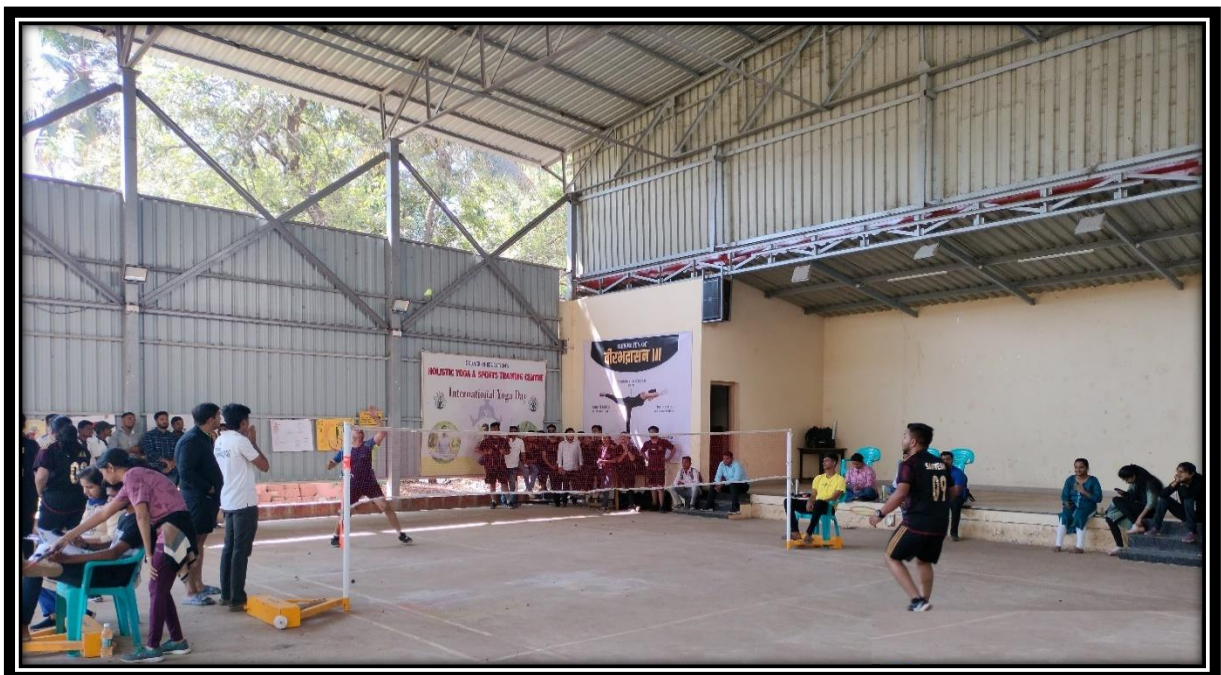

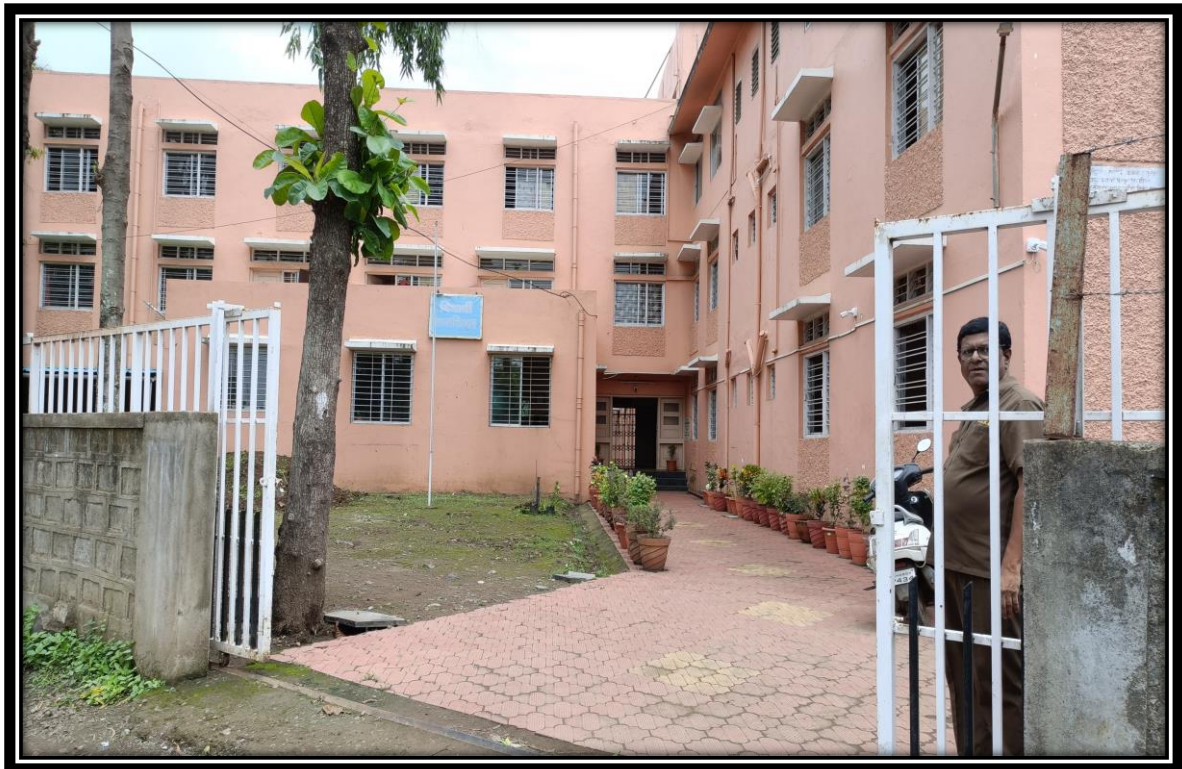

DISCIPLINE RULES FOR STUDENTS AND THE CONSEQUENCE FOR DEFAULT

DISCIPLINARY AUTHORITY

- The Principal in assistance with disciplinary committee shall be responsible for the maintenance of discipline amongst the students of the College.
- The Principal in assistance with disciplinary committee, may either suo moto or on a report received from the teacher or staff, take cognizance of any lapse or a serious breach of discipline and levy suitable punishment, which may even include but not limited to, reprimand, fine, suspend, withholding of examination forms, withholding of benefits like scholarships etc and expulsion of a student from the College.
- All students admitted to the college and hostel are subject to the discipline and control of the college authorities. The students are required to adhere strictly to the existing rules and regulations and such as may be framed from time to time by the college authorities. In case of breach of discipline, the Principal shall have the power to reprimand, fine, suspend, rusticate or even expel the concerned student(s) from the College.

ACTS OF MISCONDUCT AND INDISCIPLINE:

• CATEGORY-I

- i. Causing disturbance within the College premises, Laboratory or Reading Room, Library, Common Room, Playground or Hostel, Canteen, Gymnasium and such other places in the College Campus.
- ii. Any act leading to diverting the attention of the students from the Lectures or of the teacher from Teaching.
- iii. Insubordination and/or disrespect to the teacher within or outside the College premises.
- iv. Habitual inattention to classwork and assignments.

- v. Disturbing a class from outside by loitering aimlessly in the corridors, making noise.
- vi. Picking up quarrel with the teaching or non-teaching staff or with other students.
- vii. Using abusive language and abuses in the College premises or 'Sports-grounds'
- viii. Smoking within the College campus.
- ix. Playing any kind of musical instrument inside the class or outside during class hours.
- x. Hunger strikes, dharnas, group bargaining and any other form of protest by blocking entrance or exit of any of the academic and/or administrative complexes or disrupting the movements of any member of the College.
- xi. Furnishing false certificates or false information in any manner to the College.
- xii. Teasing or disrespectful behaviour or any misbehaviour with a boy/girl student, staff member/ visitor.
- xiii. Causing or colluding in the unauthorized entry of any person/guest into the College Campus or in the unauthorized occupation of any portion of the College premises, including residential quarters/hostels or residence by any person.
- xiv. Unauthorized occupation of the hostel rooms or unauthorized acquisition and use of College furniture in one's hostel room or elsewhere.
- xv. Damaging or defacing, in any form any property of the College or the property of any member of the College community.
- xvi. Not disclosing one's identity when asked to do so by a faculty member or employee or security staff of the College who is authorized to ask for such identity.
- xvii. Improper behavior while on tour or excursion.
- xviii. Coercing the medical staff to render medical assistance to persons not entitled for the same or any other disorderly behavior in the Health Centre on College campus.
- xix. Blockade or forceful prevention of any normal movement of traffic, violation of security or safety rules notified by the College.
- xx. Littering of any kind of waste including plastic waste in the College buildings, grounds/roads/premises.
- xxi. Disturbing other students/ teachers using a mobile phone inside the class or outside during class hours
- xxii. Driving and parking the vehicles on College campus in violation of guidelines to that effect.
- xxiii. Distributing any material related to political parties/movements.
- xxiv. Any other act which may be considered by the Principal or any other competent authority to be a minor act of violation of discipline and conduct.

• **CATEGORY-II**

- i. Repetition of acts given under Category-I of indiscipline in spite of repeated warnings and penalties imposed.
- ii. Attending the College dressed in a manner contrary to social norms prevailing from time to time or violation of dress code if any.
- iii. Indecent exposure in a proactive manner or behaving in a manner tending to rouse baser passions among the members of the same or opposite sex.
- iv. Disfiguring the walls, floors, furniture etc. of the College.
- v. Forcibly entering/ reaching places which have restricted entry or unauthorizedly handling of equipment or performing acts which would be a threat to one's life.
- vi. Instigating others to commit acts of indiscipline.
- vii. Engaging in any attempt at wrongful confinement of any member of the faculty, staff, student or anyone camping inside the College Campus.
- viii. Any Intimidation of or insulting or abusive behaviour towards a student, staff or faculty or any other person.
- ix. Wanton destruction of College properties.
- x. Consuming or possessing narcotic drugs or other intoxicants or alcohol anywhere in the College premises.
- xi. Indulging in criminal acts of any kind under the law of land including gambling and possession of arms/weapons.
- xii. Arousing communal, caste or regional feelings or creating disharmony among students.
- xiii. Demonstration of disloyalty to the country, its constitution and its flag.
- xiv. Ragging of any kind tending to cause physical and mental torture to other students or forcing others to submit to indignity and nuisance.
- xv. All acts of violence and all forms of coercion such as gheraos, sit-ins or any variation of the same which disrupt the normal academic and administrative functioning of the College and or any act which incites or leads to violence.
- xvi. Gheraos, laying siege or staging demonstrations around the residence of any member of the College or any other form of coercion, intimidation or disturbance of right to privacy of the residents of the campus.

- xvii. Sexual harassment of any kind which shall also include: unwelcome sexual proposition/ advancements, sexually graphic comments of a body unwelcome touching, patting pinching or leering of parts of the body or persistent offensive or unwelcome sexual jokes and or comments as per Sexual Harassment of Women at Workplace (Prevention and Redressal) Act 2013.
- xviii. Committing forgery, tampering with the Identity Card or College records, impersonation, misusing College property (movable or immovable), documents and records, tearing of pages of, defacing, burning or in any way destroying the books, journals, magazines and any material of library or unauthorized photocopying or possession of library books, journals, magazines or any other material.
- xix. Any act of moral turpitude.
- xx. Use of abusive, defamatory, derogatory or intimidatory language against any member of the College Community.
- xxi. Any other act or acts which the Principal considers as major acts of misconduct and indiscipline.
- xxii. Publishing or posting derogative comments against any student/teaching staff / administrative staff of the college or any other person on the social media.

In addition to above Memoranda, petitions or complaints from individual student of the College to any higher authority must be submitted through the college. Any canvassing against the college or university would be deemed serious misconduct for which such students may be expelled from the college.

DISCIPLINE RULES FOR STUDENTS AND THE CONSEQUENCE FOR DEFAULT

PUNISHMENT

- **CATEGORY-I**

- 1) Admonition/Reprimand.
- 2) Sending the student out of his class and not letting him into his class up to a maximum of two consecutive periods.
- 3) Marking the student absent on repeating the misconduct at Sr. No. 2.
- 4) Fine up to Rupees Twenty Thousand depending upon gravity of the issue.
- 5) Recovery of any kind, such as scholarship/fellowship, any dues, cost of damages, etc.
- 6) Withdrawal of any or all facilities available to a student as per, various Goa University Act and College Rules (such as Scholarship/Fellowship, Hostel etc.) permanently or for a time period up to Four semesters.
- 7) Stoppage of any or all academic processes.
- 8) Rustication up to two semesters and/or Declaring any hostels, premises, building or the entire College Campus out of bounds to any students.

- **CATEGORY-II**

- 1) Cancellation of admission or withdrawal of degree or denial of registration for a specified period.
- 2) Rustication up to Ten semesters and/or declaring any part or the entire College Campus out of bounds.
- 3) Fine up to Rupees Fifty Thousand depending upon gravity of the issue.
- 4) Expulsion.

MOOT COURTS

Legal education being professional course demands special focus on professional skills development in Court room environment along-with the training in knowledge of law in the classroom settings. As the BCI, UGC, NEP emphasis on these practical skills development aspects, Shahaji Law College, Kolhapur through its curriculum has fully integrated these skills related aspects in it. Moot Court stimulates real Court proceedings allowing students to practice their advocacy skills argue cases and engage in legal debates. Mooting is the significant activity where students argue on fictional or hypothetical cases in an artificially created environment

The College has a well-equipped Moot Court Hall with proper judicial settings to help the undergraduate students with their practice, preparation and presentations for Moot Court competitions. The Moot Court Hall has a seating capacity of 100 students. The Moot Court Committee will be hosting the annual Intra-University Moot Court Competitions, Internal Moot Court competition as well as Moot Courts in vernacular language which is one of the Institution's flagship events.

The College selects the students for representing the College in various national and international Moot Court Competitions through the Intra Moot Competition conducted every year and provide them with sufficient support to participate in various competitions.

Shahaji Law College has been playing a significant role in developing a robust Mooting culture among the law students. Shahaji Law College has brief history in conducting Intra-University Moot Court Competitions, Internal Moot Court competitions, Mock Trials and also encourage to participate students in International, National and State level and University Moot Court competitions in every academic year.

Moot Court Hall of the College is a spacious, ICT enabled infrastructure which accommodate upto 100 students providing a suitable environment for Moot Court, mock trial and other legal exercises. Lectures and Role plays on Alternate Dispute Resolution (ADR) are conducted in this hall which not only ensures theoretical background of ADR mechanisms in the class but also trains law students in various modes of ADR through practical sessions as well as by exposing and participation in Lok Adalats, Family Court Mediation, etc.
