
- 1) To confirm the minutes of the previous meeting


④ To discuss plans to focus and improve the soft skills of the students.

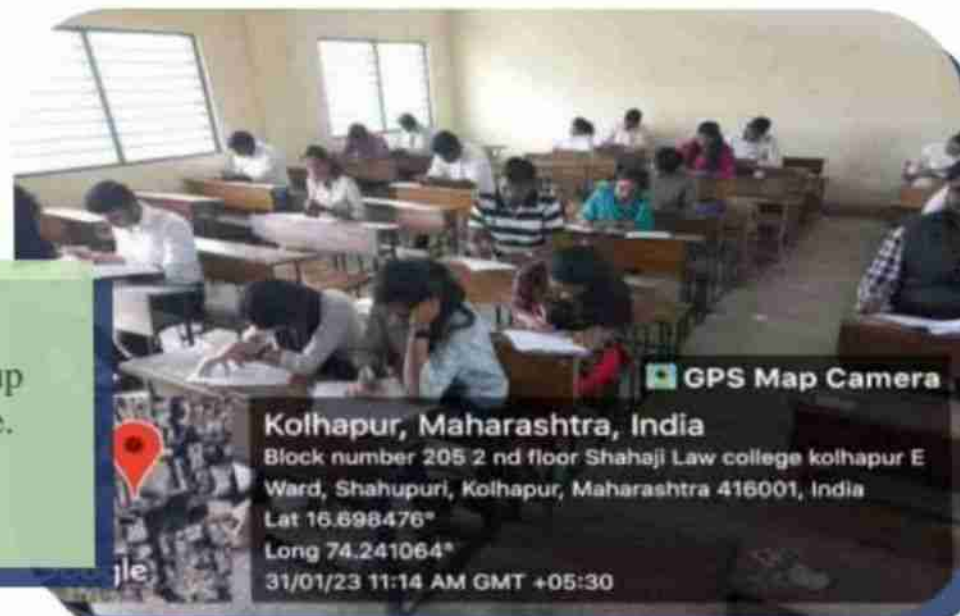

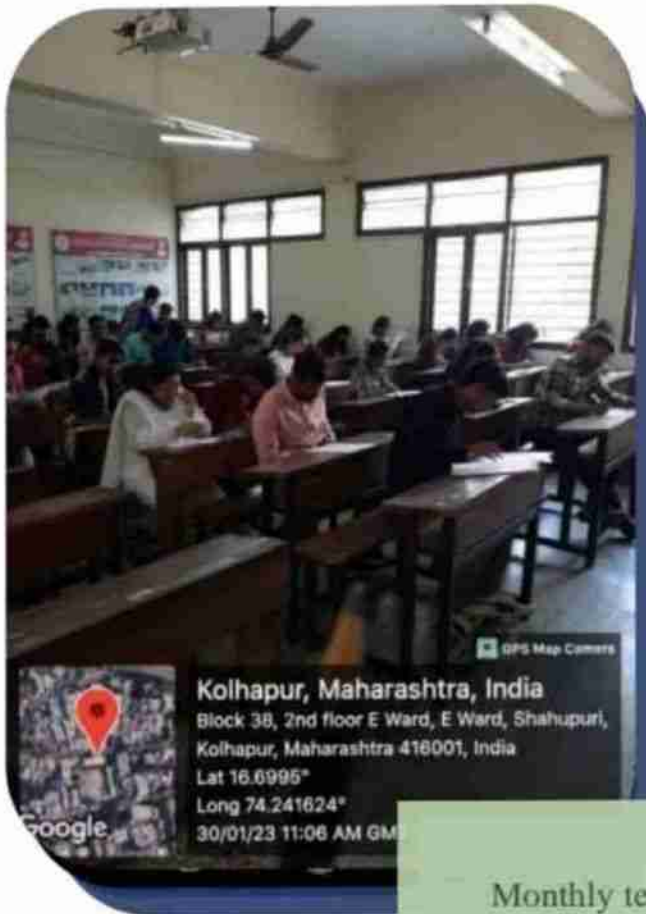
